Good morning,

This is a request for copies of and the opportunity to inspect records under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552 and the Privacy Act, 5 U.S.C. § 552a. This request should be considered under both statutes to maximize the release of records.

RECORDS SOUGHT

- 1) All versions, including original and amended versions, of an Office of Government Ethics (OGE) Form 278e submitted by Acting Attorney General Matthew Whitaker since October 1, 2017.
- 2) All versions, including original and amended versions, of an Office of Government Ethics Form 278-T submitted by Acting Attorney General Matthew Whitaker since October 1, 2017.

### **EXPEDITED PROCESSING**

Under 5 U.S.C. § 552(a)(6)(E), a request is to be given expedited processing when the requester demonstrates a “compelling need.” I am seeking expedited treatment for this request.

- This request involves a matter of widespread and exceptional media interest. Acting Attorney General Matthew Whitaker’s appointment has generated significant controversy for a number of reasons, including, relevant to this request, about his financial holdings and the delay in making his financial disclosure materials available for public inspection. The Justice Department on November 20, 2018, released two Form 278e’s filed by Mr. Whitaker that indicated there were multiple revisions submitted in the past month. Mr. Whitaker’s tenure as acting attorney general is temporary and the duration is dependent on the nomination and confirmation of an attorney general, and the public in the meantime has an interest in understanding how his financial reporting has been handled as soon as possible.

### **INSTRUCTIONS REGARDING SCOPE AND BREADTH OF REQUESTS**

Please interpret the scope of this request broadly. The department is instructed to interpret the scope of this request in the most liberal manner possible short of an interpretation that would lead to a conclusion that the request does not reasonably describe the records sought.

### **EXEMPTIONS AND SEGREGABILITY**

Under the FOIA Improvement Act of 2016, agencies must adopt a presumption of disclosure, withholding information “only if . . . disclosure would harm an interest protected by an exemption” or “disclosure is prohibited by law.”

The FOIA Improvement Act of 2016 also amended the FOIA as follows (5 USC 552(a)(8)):

- (A) An agency shall—
  - (i) withhold information under this section only if—

- (I) the agency reasonably foresees that disclosure would harm an interest protected by an exemption described in subsection (b); or
- (II) disclosure is prohibited by law; and
- (ii) (I) consider whether partial disclosure of information is possible whenever the agency determines that a full disclosure of a requested record is not possible; and
- (II) take reasonable steps necessary to segregate and release nonexempt information. . .

If it is your position that any portion of the requested records is exempt from disclosure, I request that you provide an index of those documents as required under *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973), cert. denied, 415 U.S. 977 (1974). As you are aware, a Vaughn index must describe each document claimed as exempt with sufficient specificity “to permit a reasoned judgment as to whether the material is actually exempt under FOIA.”

Moreover, the Vaughn index “must describe each document or portion thereof withheld, and for each withholding it must discuss the consequences of disclosing the sought-after information.” Further, “the withholding agency must supply ‘a relatively detailed justification, specifically identifying the reasons why a particular exemption is relevant and correlating those claims with the particular part of a withheld document to which they apply.’”

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. Claims of nonsegregability must be made with the same degree of detail as required for claims of exemptions in a Vaughn index. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

Further, “the withholding agency must supply ‘a relatively detailed justification, specifically identifying the reasons why a particular exemption is relevant and correlating those claims with the particular part of a withheld document to which they apply.’”

In addition, I ask that your agency exercise its discretion to release records which may be technically exempt, but where withholding serves no important public interest.

#### **ADDITIONAL INSTRUCTIONS REGARDING REQUEST**

If a portion of the responsive records become available before the entire request is complete, I respectfully request that your agency provide records on a rolling basis.

**FORMAT**

I request that any releases stemming from this request be provided to me in digital format via email, a compact disk or other like media.

**FEE CATEGORY AND REQUEST FOR A FEE WAIVER**

I request to be categorized as a representative of the news media. 5 U.S.C. § 552(a)(4)(A)(ii). I am a reporter for BuzzFeed News, and my articles reach thousands of readers every week. The requested records will inform my reporting and I intend to use these records in my capacity as a reporter.

Further, I request that any remaining fees be waived because disclosure of the responsive records “is in the public interest” as “it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in the commercial interest of the requester.” 5 U.S.C. § 552(a)(4)(A)(iii). The subject of the records is financial information about Acting Attorney General Matthew Whitaker and the extent to which he has had to amend or revise his financial disclosures. The records are likely to contribute to the general public’s understanding of its government because they will show how agencies enforce financial reporting rules and what information Mr. Whitaker did not include or needed to change in earlier versions of his disclosures. Moreover, as a reporter for BuzzFeed News, I am able to distribute this information broadly to the public.
