It also includes the room, supplies, and equipment utilized during the visit. The charge is not based on time spent in the facility or with clinicians.

Charge # [REDACTED] (ELECTROCARDIOGRAM) is the facility charge for an EKG. A test that evaluates the electrical activity of your heart.

Charge # [REDACTED] (TROPONIN QUANTITATIVE) is a laboratory test that aids in determining if heart damage has occurred.

A detailed review of the medical record was completed. Medical record documentation supports charge # [REDACTED] (ED VISIT LEVEL 5) was appropriate for the following reasons:
