This letter is in response to your request of August 14, 2018, for an individual waiver of the Nonmanufacturer Rule (NMR) under NAICS Code 339999 (Miscellaneous Equipment) to allow a set-aside for small business for the proposed acquisition. This acquisition is a follow-on contract with the previous individual waiver granted on August 28, 2012. Based on the justification below, a waiver of the NMR is hereby established for a one-time purchase of diving and safety equipment.

The request for an individual waiver of the NMR is approved. An explanation of the determining factors follows.

The waiver of the NMR on an individual procurement is provided for in section 8(a)(17) of the Small Business Act, 15 U.S.C. § 637(a)(17), and section 121.406(b)(5) of title 13 of the Code of Federal Regulations, 13 CFR § 121.406(b)(5). At a minimum, an individual NMR waiver request must include the specific item to be waived, why the specific item is required, the proposed solicitation number, the NAICS code, the dollar amount of the procurement, a brief statement of the procurement history, and a Statement of Work (for contracts expected to exceed \$500,000). 13 CFR § 121.1204(b)(1).

In addition, the contracting officer must provide a determination that no small business manufacturer can reasonably be expected to offer the product(s) required under the solicitation. This determination must be supported by a narrative of market research and supporting documentation. 13 CFR § 121.1204(b)(1)(iii).

In this instance, the waiver, under solicitation number SPE8EJ18R0001 and NAICS code 339999, has been requested for the purchase of diving equipment and related supplies. The solicitation is valued at As you provided in your request, this special operations equipment is necessary to support and protect troops.

The items to be procured were previously obtained under an individual waiver granted to solicitation SPM8EJ-12-R-0002. For this follow-on procurement, you conducted market search to determine whether any small business concerns had entered the marketplace. Your market research included a posting a Sources Sought notice from July 16, 2018 through July 31, 2018. There were no responses to that posting. As such, you demonstrated that there are no small businesses capable of meeting the requirements of the solicitation.

Thus, an individual waiver of the NMR is justified.

This waiver applies only to this one-time award and does not apply to modifications outside the scope of the contract or other procurement actions. The effect of this waiver is to allow an otherwise qualified small business to supply the product of an other-than-small manufacturer or processor on this intended small business set-aside contract. However, it must be emphasized that this waiver of the NMR <u>does not waive other legal requirements</u> applicable to Government procurements, such as the Buy American Act and the Trade Agreements Act.

Please also note that this individual waiver will expire on August 30, 2019. If you need an extension, please contact our office.
