Details: On 4/28/1998, the attendees at the Conference on Animal Rights Terrorism were welcomed by United States Attorney (USA), District of Utah, David Schwendiman, and United States Department of Justice (DOJ) Section Chief, James S. Reynolds. During the welcome, USA Schwendiman outlined the necessity for the conference due to the common nature of the crimes being committed and the persons involved, throughout the United States.

Intelligence Research Specialist (IRS) [redacted] of FBIHQ, defined Animal Rights Terrorism, and briefly explained some of the current trends seen on a national scale. Salt Lake City Police Detective [redacted] then addressed the
