

Thomas, pursuant to our brief conversation today, this is to confirm my request for a copy of whatever Mr. Beers has submitted regarding Ashley Neese. As I mentioned, I have asked OPR for a copy, but they were not yet comfortable providing one, and I advised that I plan to ask the USAO. He indicated that he did not object to me asking and that your office had to make its own assessment of whether they would provide the information.

To state the obvious, there is no way for Ashley to defend herself without knowing the allegations and their basis, and without knowing whether Mr. Beers has failed to provide all relevant information. The selective mention of Ashley's name in an unrelated public filing to which she cannot object is shameful and reflects an agenda and a bias that cannot be overlooked. I respectfully urge the office to allow me access to the material. If we need to agree on some sort of protective order I am of course willing to do so.

Last, could you let me know if Ashley's administrative leave is with pay. I assume it is since we have not seen the information and have not yet had a chance to respond but I would like to make sure. Thank you. David.
