## Dear FOIA Officer:

Pursuant to the Freedom of Information Act, 5 U.S.C. Section 552, I request any and all information that pertains and/or reflects the history of any and all requests made pursuant to FOIA related to Judith Socolov née Coplon aka "Sima."

In addition, I request the production of any and all information that pertains to and/or reflects declassifications of all and any files also related to Judith Socolov née Coplon aka "Sima".

I request that the FBI conduct a broad search for the requested information, as I hope to gain information on FOIA requests for any special indices or other indices maintained by any division, section, office, bureau, resident or other component of the FBI. This search should include, but not be limited to, information in the:

- Central Records System ("CRS") (not limited to the Universal Index component of CRS);
- FBI headquarter ("FBIHQ") files; Field office files in the relevant field offices e.g., the Albany, Baltimore, Boston, Buffalo, Cincinnati, Denver, Detroit, El Paso, Houston, Kansas City, Los Angeles, Memphis, Milwaukee, Newark, New Haven,

Philadelphia, Pittsburgh, Richmond, San Francisco, San Juan, Seattle, Springfield, IL, Washington, DC field offices;

- Investigative Case Management ("ICM") files or indices;
- Electronic Case File (ECF);
- Electronic Surveillance (ELSUR) indices;
- The card system in the relevant field offices e.g., the Albany, Baltimore, Boston, Buffalo, Cincinnati, Denver, Detroit, El Paso, Houston, Kansas City, Los Angeles, Memphis, Milwaukee, Newark, New Haven, Philadelphia, Pittsburgh, Richmond, San Francisco, San Juan, Seattle, Springfield, IL, Washington, DC field offices;
- The card system at FBIHQ;
- Reports from FBI Laboratories where indicated;
- Handwritten notes:
- So-called 'personal' files; and
- Restricted documents.

In addition to the foregoing, I request information on all previous FOIA requests for information on Sima and all correspondence pertaining thereto, including not only Freedom of Information Act requests but congressional, news media or other requests. In particular, this should include the requests submitted by The Office of the United States Attorney for the Southern District of New York. With respect to requests for ELSUR records, I request information on prior FOIA requests not only any records pertaining to any electronic surveillance to which "Sima" was the target, but also any "overhears" or "mentions" pertaining to her.

I understand that your office produces declassification reviews of the FBI's production of declassified materials on a biannual basis when required. This history is important for my research.
