JFLCC INTELLIGENCE ENTERPRISE CONDUCTS ANALYSIS AND INTELLIGENCE OPERATIONS IN ORDER TO ANSWER THE COMMANDER PRIORITY INTELLIGENCE REQUIREMENTS AND TO PROVIDE INTELLIGENCE SUPPORT TO FORCE PROTECTION FOR FOREIGN INTELLIGENCE AND COUNTERINTELLIGENCE THREATS TO DOD EQUITIES AND SITUATIONAL AWARENESS OF MIGRANT MOVEMENT IN THE JOINT OPERATIONS AREA AND THE AREA OF INTEREST.

2. (U) GENERAL.

2.A. (U//FOUO/LES) SITUATION. THE SECURITY OF THE UNITED STATES IS IMPERILED BY A DRASTIC SURGE OF ILLEGAL DRUGS, DANGEROUS GANG ACTIVITY AND EXTENSIVE ILLEGAL IMMIGRATION THREATENS SAFETY OF CITIZENS AND UNDERMINES THE RULE OF LAW. THE SITUATION AT THE BORDER HAS REACHED A POINT OF CRISIS AND POTUS HAS TAKEN ACTION TO SECURE OUR BORDERS. THE ACTING SECDEF APPROVED DOD SUPPORT OF THE DEPARTMENT OF HOMELAND SECURITY (DHS) AND THE UNITED STATES CUSTOMS AND BORDER PROTECTION (CBP) TO COUNTER THE THREAT THESE PRESENT TO OUR NATIONAL SECURITY.

2. C. (U//FOUO//LES) MOST DANGEROUS COURSE OF ACTION. BORDER CROSSING WILL INCREASE, AND THE ADDITION OF DOD RESOURCES ALONG THE SOUTHWEST BORDER WILL RESULT IN AN INCREASE IN APPREHENSIONS. IT IS LIKELY THAT CARTELS WILL MODIFY OPERATIONS TO COUNTER THE SURGE IN SECURITY FORCES ALONG THE OPERATIONAL ENVIRONMENT TO MAINTAIN THE FLOW OF ORGANIZATIONAL REVENUE. THESE CHANGES MAY INCLUDE AN INCREASE IN VIOLENCE AGAINST DOD PERSONNEL.
