3. All SOM Data and all associated available metadata, including metadata described in Appendix A, if available. The SOM Data including both source native files and images, plus associated metadata is to be provided in the industry standard Concordance format of .dat and .opt, also known as a Relativity Load File.

4. All necessary information in order to install the Relativity Load File into a new Relativity workspace, including but not limited to usernames, passwords, Load File field descriptions, etc. will be seized at the time the warrant is executed.
