This letter is in response to your Freedom of Information Act (FOIA) request dated and received on July 27, 2018. You requested a log of all Equal Employment Opportunity complaints, including their causes and their final determinations, that have been filed against the Department of Housing and Urban Development since January 20, 2017.

With regard to Exemption 6, your appeal should address the nature of the overriding public interest in disclosure that outweighs the personal privacy interest protected by the exemption. 
