Officer contacted this writer via radio stating that he needed assistance in Unit 7 A-zone. Upon arrival I did notice Offender Eddie Shorty #26507 on his call floor and Nurse was administering CPR to Offender Eddie Shorty #26507. I then notified Area 1 control to call the ambulance and they arrived approximately at 04:12 hrs. The paramedics pronounced Offender

On May 30, 2018 at approx 0330hrs, I Officer [REDACTED] was relieved by Officer [REDACTED] in Unit 12 to go finish count and do medication Pass in the lockdown Unit 7. I Officer [REDACTED] called Nurse [REDACTED] and I escorted Nurse [REDACTED] to Unit 7. While I was on A Zone [REDACTED] hit his cell door and advised this writer he had a problem in his cell. I Officer [REDACTED] went to see cell 2-11 and discovered offender Eddie Shorty#26507 was unresponsive and bloody. I Officer [REDACTED] opened the cell door and told [REDACTED] step out the cell and go to the hallway in which he complied. Nurse [REDACTED] proceeded to Administer CPR on offender Eddie Shorty#26507. I immediately called [REDACTED] for assistance, he arrived a shortly after. I Officer [REDACTED] then went to the infirmary to get the stretcher.
