NOTICE TO RECIPIENTS/USERS OF FACIAL RECOGNITION IMAGE RESULTS

Recipients/Users of Motor Vehicle Commission ("MVC") facial recognition image results are hereby advised that the MVC makes no representations as to the accuracy of a potential image match derived from the use of a manually uploaded image that is "scrubbed" against the MVC Image Repository.

Recipients/Users are specifically cautioned that potential image matches resulting from the use of facial recognition software are not necessarily indicative of a positive identification, and, therefore, no action, including arrests, should be premised solely on image scrub results provided by the MVC. Facial recognition software is an investigative tool; therefore image matches should only be used as lead information for establishing identity, which may require further confirmation through the use of traditional investigative procedures.

Recipients/Users are further advised that the obtainment and use of images acquired from the MVC Image Repository are strictly governed by both the Federal and New Jersey Drivers' Privacy Protection Act ("DPPA"), 18 U.S.C. § 2721 et seq. and N.J.S.A. 39:2-3.3 et seq., and the disclosure of MVC images is further restricted by New Jersey law, N.J.S.A. 39:3-10f2, which limits the release of images only to law enforcement and government entities, or private persons or entities acting on their behalf, for use in carrying out official functions.

Improperly obtaining and disclosing MVC images in violation of the Federal and New Jersey DPPA is a crime of the fourth degree and persons found to have committed such an offense can be held liable, in a civil action in the Superior Court, by the individual to whom the information pertains for an award of actual damages, punitive damages, and reasonable attorney's fees and litigation costs.

Receipt and use of MVC images shall constitute a Recipient's/User's acknowledgement and agreement to defend, indemnify, protect, and save harmless the MVC, its agents, servants and employees from and against any and all suits, claims, losses, demands or damages of whatever kind or nature, including, but not limited to, personal injury claims, wrongful death claims, property damage claims, and contractual liability claims, arising out of or claimed to arise out of the Recipient's/User's obtainment and/or use of any image acquired from the MVC. Recipient's/User's shall, at their own expense, appear, defend and pay all charges for attorneys and all costs and other expenses arising from such suit or claim or incurred in connection therewith. If any judgment shall be rendered against the MVC for which indemnification is provided under this paragraph, the Recipient/User shall at its own expense satisfy and discharge the same.

Recipients/Users further acknowledge and agree that the NJMVC assumes no obligation to indemnify or save harmless any Recipient/User, their agents, servants, employees, contractors or subcontractors for any claim which may arise out of their obtainment and/or use of any images acquired from the MVC.
