The South Dakota Department of Public Safety has received your written request for documents and records pursuant to SDCL 1-27 et seq.

Your request is dated July 26, 2017, and I, as the public records officer for the department, received it on August 2, 2017. I confirmed via email on August 16, 2017, that we were evaluating your request and would have a determination soon. You are requesting documents related to Facial Recognition Technology (FRT).

Following is the status of your request:

- Any manuals, memos, policies, or other guidelines (item #1 in your request) for using the FRT system are the property of Morpho Trust (f/k/a L-1) and are exempt from disclosure under SDCL 1-27-1.5 (3) and SDCL 1-27-1.6 (6).
- We do not have a written policy to provide (item #2 in your request). Therefore, we do not have any documents that comply with your request. However, procedurally we only respond to requests that come through the South Dakota Fusion Center, and we have one designated staff person who handles all requests.
