Mr. Wagner,

Your request has been assigned FOIA Case #18-081 (18-079, referred to USACE), and is being process IAW with AR 25-55. I have responded to your request and inquiries in a timely manner. You requested that we informed you if fees would exceed \$500. Your fee category is "commercial requester" and there is no change in the estimate of fees that I provided to you. You do not qualify for a fee waiver. Also, I provided you a copy of AR 25-55 with fees requirements. Attached is a copy of the DD Form 2086 that I used to determine your estimated fees (used professional hours rate). We require requesters to pay 1/2 the cost of fees up front when the fees exceeds \$250.

As previously stated, we referred your initial request to USACE, based on the contact number you provided. They terminated the contract of your client, so all records pertaining to this determination falls under their purview.

I have cc'd our Attorney, MAJ Warren, on this email, should you want to discuss your request any further.

Dear Mr. Nesbitt:

We have cooperated in good faith with USASOC in an attempt to reach a compromise on the scope of our February 20, 2018 FOIA request, but it is becoming increasingly clear, based on USASOC's conduct over the past two weeks, that USASOC does not intend to comply with our requests or produce any documents.

We filed our FOIA request with USASOC on February 20, 2018. Nothing substantive has happened since then. To date, USASOC has not even assigned our request a FOIA control number. Instead, immediately upon receipt of our request, USASOC attempted to refer our request to the U.S. Army Corps of Engineers, Omaha District ("USACE").

On February 23, 2018, we objected to the referral and informed USASOC that our requests were directed to USASOC and 10th SFG and not USACE. In reply, USASOC indicated that USACE would have to review any responsive documents located in the search, thus requiring their involvement.

On February 26, 2018, we reiterated that our requests are directed to USASOC and 10th SFG and that USASOC is required to conduct an independent search of its records without the interference of USACE. As you know, USASOC is a separate organization within the Department of the Army that is authorized to receive and act independently on FOIA requests. It's therefore difficult to understand why USASOC is unable to

conduct a search of its own records and instead needs the assistance of USACE. USASOC is not relieved of the responsibility of conducting a search and making a release decision.

In response, USASOC switched its focus to the level of difficulty of the search and the resulting fees. On February 27, 2018, we spoke on the phone about limiting the scope of our requests to allow USASOC to quickly and efficiently conduct the search. On February 28, 2018, under a reservation of rights, we limited our February 20, 2018 FOIA to 5 requests and the period of December 1, 2016 to present. On Monday March 5, 2018, USASOC responded that this significantly narrowed scope would cost not less than \$4,224.00.

On March 6, 2018, we informed USASOC that this fee estimate was unreasonable considering the narrowed scope of our requests, but in the spirit of cooperation, we narrowed our requests further to the period of December 1, 2017 to February 6, 2018 (just over two months) and provided USASOC with specific search terms. Despite narrowing our requests a second time, USASOC responded that the fee estimate of \$4,224 would not change.

On our call on March 7, 2018, you informed me that the \$4,224 fee estimate was based on a search of the accounts and records of 30,000+ USASOC personnel (and this was the reason for such high fees), but that the fee estimate could be significantly reduced if we provided you with a specific list of custodians within USASOC and 10th SFG to search. Accordingly, we narrowed our request a third time on March 8, 2018 and provided USASOC with 4 specific USASOC custodians as well as operators and search terms for each custodian.

Despite limiting the search to 4 specific USASOC custodians, 5 specific search terms, and the 2 month period of December 1, 2017 to February 6, 2018, USASOC now claims that the fees have increased to \$7,568.00. This fee estimate is unreasonable, nonsensical, and completely at odds with the representations you made to us on March 7, 2018 that the fees would be reduced if we could provide USASOC with specific custodians for the search.

Further, your recent statement that we, "may want to pursue this matter other than through FOIA" is yet another attempt to relieve USASOC of its FOIA obligations. USASOC's conduct amounts to stonewalling and an active evasion of our requests. We have adequately described the records we are seeking and have worked diligently with USASOC to bring about a resolution, yet USASOC has not advanced our records search and has in essence told us we should go somewhere else. USASOC has impeded our ability to promptly obtain records. This is unacceptable.

We ask that you reconsider your position and provide us with a reasonable fee estimate in accordance with your representations of March 7.

Mr. Wagner,

Our IT department ran a search over the past 24 hrs and captured more than 2.5 gb of information, based on the search terms you provided. These records are mainly PST files and folders. To make them reviewable, new folders must be created for information to be placed for us to review, which may take another 48 hrs (IT work); and it may take us 2.5 weeks (100 hrs) reviewing the material. So your new fee estimate is \$7568 (172 hrs search & reviewing X \$44.00 per hr); and this cost could go north or south of this estimate, based on the information located. Furthermore, you may not get all of the information after we apply FOIA exemptions to the material. Also, the same rule apply to fees; 1/2 the cost up front for us to begin processing your request. You may want to pursue this matter other than through FOIA.

How do I request a search?

When will my search results be available?

We don't know. It depends on the complexity of the search and the availability of system resources. But we will contact you as soon as results are ready for download.

How long does it take for a search to be queued into the System?

It depends on the volume of incoming requests. Allow at least 72 hours.

How do I get a status of my search request?

If XXXXXXXX has confirmed receipt of your request, rest assured that we will let you know when results are available. But if you need to know the status, send an email to XXXXXXXX – be sure to include the Search number.

Can XXXX search for attachments to emails?

Yes and no. The System treats most non-encrypted attachments as part of the message itself. So we can search some attachments, but not whether there *is* an attachment.

Who decides whether an account is journaled or not?

The provisioning organization makes that determination when an account is set up.

Can my organization make all of its user accounts journaled accounts?

Yes, if necessary, but it's going to cost you a lot more for each account (because there will be extra storage costs).

Thank you for your response.

Considering that we narrowed our February 20, 2018 FOIA letter to 5 requests, we were surprised to receive an estimate of \$4,224.00. This seems unreasonable given the significantly narrowed scope of our requests and the fact that our requests target a specific project at Fort Carson, Colorado.

Nonetheless, under a full reservation of rights, we will agree to limit our FOIA further to the time period of December 1, 2017 to February 6, 2018 and the following:

#1 All documents, including communications between and among USACE, USASOC, and/or 10th SFG, concerning delays to the completion of the Project.

#5 All documents concerning USASOC and/or 10th SFG's plans to occupy and use the Project. We believe this category will include not only written communications, but also internal memoranda, notes, reports, etc.

#9 All documents, including communications between and among USACE and/or USASOC and 10th SFG, concerning the termination of Watts' Contract at the Project.

#13 All documents referring or relating to the unavailability of security guards, military police, or USASOC/10th SFG personnel to provide security and access at the Project beginning in February 2018.

#14 All documents, including communications between and among USACE and USASOC and/or 10th SFG concerning the estimated time for completion of the Project following the termination of Watts' Contract.

We ask that you use the following operators and search terms when searching USASOC and 10th SFG's records:

- Watts AND access
- Watts AND security
- Watts AND (terminate OR termination)
- Watts AND schedule
- Watts AND delay

In addition, as set forth in my e-mail of February 28, 2018, we are seeking not only e-mails and communications (i.e., the transmittal of information by any means), but also documents, letters, memoranda, reports, photographs, and other records responsive to the above referenced limited requests. Please ensure that your search covers these categories of records.

We are cooperating in good faith with USASOC and have narrowed our requests twice and feel that this is more than reasonable. Our request is now limited to a 2 month period. The narrowing of our request should significantly reduce the search hours and fees. We ask that USASOC and 10th SFG promptly provide us with a revised fee estimate and conduct the search and produce the documents.

Mr. Wagner,

If we search our files for records (emails) that originated at/or from the USACE, we will refer the material to them for processing, based on the contract number you provided; and you will have to pay fees associated at both agencies. Your fee category is "commercial requester," you pay fees for search and review (\$44 per hour) and copying (. \$15 per page). Here is an example of fees, based on a normal search: 8 hours search & 40 hours reviewing (\$2112); and \$.15 per page (if anything is released). As stated in our conversation, based on a preliminary review of the information you are requesting, nothing may be released if the material/information is internal to a decision making (see FOIA Exemptions b3 10 USC 130b & b6, privacy concerns; b4, financial information; b5, deliberative). Even if nothing is released to you, you will still have to pay fees; paying 1/2 of the fees amount upfront. Let me know if you want us to proceed with processing your request and I will get with our IT department for an estimated fees to process your request.
