1.0 BACKGROUND

CBP is also responsible for apprehending individuals attempting to enter the U.S. illegally; stemming the flow of drugs and other contraband; protecting our agricultural and economic interests from harmful pests and diseases; protecting American business from theft of their intellectual property; and regulating and facilitating international trade, collecting import duties, and enforcing U.S. trade laws.

The United States Border Patrol (USBP), Big Bend Sector requires various children and adult clothing items. The clothing are essential for the health and wellness of the detainees while in USBP custody.
