- 4. ASSESSMENT: KSM'S REVELATION THAT HE WAS THE INDIVIDUAL WHO KILLED DANIEL PEARL WAS A SIGNIFICANT ADMISSION. THIS ADMISSION DEMONSTRATED THAT KSM HAS PROGRESSED TO THE POINT THAT HE IS WILLING TO DIVULGE TRUTHFUL INFORMATION EVEN WHEN THIS INFORMATION IS ASSOCIATED WITH A POTENTIALLY HIGH DEGREE OF PERSONAL RISK AND EXPOSURE. THE HVT INTERROGATION TEAM INTENDS TO LEVERAGE THIS IMPORTANT BEHAVIORAL SHIFT BY CONTINUING TO FOCUS ON CRITICAL THREAT INFORMATION TO INCLUDE RETURNING TO CRITICAL AREAS WHICH HAVE ALREADY BEEN ADDRESSED.
- 5. MEDICAL: KSM REMAINS STABLE WITHOUT MEDICAL RESTRICTIONS THAT WOULD SIGNIFICANTLY LIMIT INTERROGATION.
- 6. PLANS: CONTINUE TO DEBRIEF AND TO DECONFLICT PREVIOUSLY PROVIDED INCONSISTENCIES.

THE INTERROGATOR REMINDED HIM THAT IN TODAY'S SESSION HE (KSM) HAD STATED THAT HE (KSM) WAS TRUTHFUL BUT DIDN'T READILY VOLUNTEER INFORMATION. AFTER A FURTHER QUIET EXCHANGE OF WORDS, KSM SAID THAT HE HAD SOMETHING MORE TO TELL. HE THEN ASKED IF THE TDY DEBRIEFER SHOULD BE BROUGHT BACK TO THE ROOM TO HEAR WHAT HE HAD TO SAY. WHEN THE TDY DEBRIEFER RETURNED, KSM BEGAN HIS STORY

STARTING WITH EVENTS IN THAT PRECEDED DANIEL PEARL'S KIDNAPPING. KSM SPOKE WITH SOMEWHAT LOW VOLUME AND APPEARED INCREASINGLY SOLEMN AS HIS STORY UNFOLDED. HIS VOICE REMAINED GENERALLY STEADY BUT HE BROKE EYE-CONTACT WITH TDY DEBRIEFER AND INTERROGATOR AND FREQUENTLY LOOKED DOWN AT HIS LAP AS HE ADDRESSED THE ACTUAL KILLING OF DANIEL PEARL. KSM SAID THAT HE WANTED TO TELL THE INTERROGATOR AND TDY DEBRIEFER THIS BECAUSE HE HAD NOT BEEN TRUTHFUL ABOUT THE TOPIC WHEN QUESTIONED IN THE PAST. HE WANTED TO SHOW THAT HE INTENDED TO BE "TRUTHFUL ABOUT EVERYTHING." KSM APPEARS TO HAVE TAKEN A SIGNIFICANT STEP IN THE DIRECTION OF BEING TRUTHFUL. HIS DISCLOSURE ABOUT HIS ROLE IN DANIEL PEARL'S DEATH MAY HAVE DEMONSTRATED THAT HE DOES INDEED TRUST THAT HE WILL BE TREATED FAIRLY WHEN HE IS TRUTHFUL EVEN WHEN DIVULGING INCRIMINATING AND DISTURBING INFORMATION. PER TODAY'S OBSERVATIONS, THERE ARE NO INDICATIONS OF ANY PROFOUND AND PERMANENT EMOTIONAL OR PSYCHOLOGICAL HARM.
