NARRATIVE

On 07/15/2011 at about 2041 hours, SQD 239 Officer Wong and I Officer R.McGuire were sent to 294 Charles (alley) on a lost item.

Upon arrival, we spoke with the victim, a retired police officer. Melvin Whitfield Carter Jr [REDACTED] [REDACTED] said he had set his .38 special Snubnose revolver (5 shot, blued finish, unknown foreign model/make, custom grips, loaded, unknown serial number) on the rear bumper of his vehicle at about 1600 hours.

Carter said he drove out of the alley West bound towards Farrington, then drove South bound towards University.

Carter said he drove around the neighborhood for several minutes before he realized he had left the revolver on the bumper. Carter stopped, and checked the bumper, but the revolver was missing.

Carter checked the alley for the revolver, and we assisted in checking the alley, with negative results.

I gave Carter a card with a case number.

Carter said the revolver was passed down to him from his father, and he didn't have the serial number, nor manufacturer, of the revolver. Carter said the revolver had custom grips, but didn't know how to describe the grips.

I informed Sgt Salkowicz of the situation.

I put out a KOPS alert for the revolver, with the description of the gun.
