Your requests were received in the Office of the Secretary FOIA office on February 25, 2019, and assigned control numbers **OS-2019-00517, OS-2019-00518, and OS-2019-00519**. We have classified you as an “other-use” requester. As such, we may charge you for some of our search and duplication costs, but we will not charge you for our review costs; you are also entitled to up to 2 hours of search time and 100 pages of photocopies (or an equivalent volume) for free. If, after taking into consideration your fee category entitlements, our processing costs are less than \$50.00, we will not bill you because the cost of collection would be greater than the fee collected. You can expect to hear from us promptly regarding the outcome of this search.

You have asked for copies of agency records. According to our regulations, you may choose the format of disclosure for such records. Unless you specify otherwise, the Office of the Secretary will provide copies of responsive records electronically via email or on a CD-ROM disk as scanned PDF images when the responsive records exceed 50 pages.

Because we will need to search for and collect requested records from field facilities or other establishments that are separate from the office processing these requests, we are taking a 10-workday extension under 43 C.F.R. § 2.19. We are placing your requests under the “Normal” processing track. See 43 C.F.R. § 2.15.
