Dear Mr. Tobias:

On April 16, 2019, you filed a Freedom of Information Act (FOIA) request seeking the following:

Any correspondence, including email attachments, between Susan Combs and any individual with an email that ends in one of the following addresses: @api.org, @coga.org, @chk.com, @carrizo.com, @murphyoilcorp.com, conocophillips.com, @marathonoil.com, and/or @phillips66.com.

This request seeks records produced between March 1, 2018 and the date this request is processed.

Your request was received in the Office of the Secretary FOIA office on April 17, 2019, and assigned control number **OS-2019-00742**. Please cite this number in any future communications with our office regarding your request.

We have classified your request as a "media use request." As a "media use requester" you will not be charged for our search or review costs and are entitled to up to 100 pages of photocopies (or an equivalent volume) for free. See 43 C.F.R. § 2.39. As a matter of policy, however, the Department of the Interior does not bill requesters for FOIA fees incurred in processing requests when their fees do not exceed \$50.00 because the cost of collection would be greater than the fee collected. See 43 C.F.R. § 2.49(a)(1).

You have asked for copies of agency records. According to our regulations, you may choose the format of disclosure for such records. Unless you specify otherwise, the Office of the Secretary will provide copies of responsive records electronically via email or CD-ROM as scanned PDF images when the responsive records exceed 50 pages.

Because we will need to search for and collect requested records from field facilities or other establishments that are separate from the office processing the request, we are taking a 10-workday extension under 43 C.F.R. § 2.19. For the same reason, we are placing your request under the "Normal" processing track. See 43 C.F.R. § 2.15.
