At this time there was four subjects located in and around vehicle at the the vehicle. PAIC and BPA-Intelligence resented themselves a Border Patrol Agents and asked who the vehicle belonged to. All but one subject had a difficult time speaking and understanding the English Language. The subject that understood stated that the truck belonged to their boss. The subjects were asked where they were from and they all stated Mexico. Three of the four subjects stated that they were illegally present inside the United States without proper documentation. The driver of the vehicle stated that he was a Lawfully Admitted Permanent Resident (LAPR) which we were able to confirm through record checks. The other subjects identified as, were all advised that they were under arrest for being illegally present inside the United States. The driver who was as LAPR was released from the scene and were all transported back to the Beecher Falls Border Patrol Station for further processing. At approximately 5:45 p.m. the same Georgia plated **Ford F-250** was seen leaving the area. PAIC was also <u>obser</u>ving the area and was able to confirm that driving the Ford F-250. PAIC had seen a photo of earlier in the day that was obtained through record checks. BPA-Intelligence followed the vehicle to I-91 South near White River Junction, VT. noticed that even though this same vehicle was encountered just BPA-Intelligence hours earlier with four subjects, (three of which were apprehended and were currently in custody) there appeared to now be at least six subjects in the vehicle. Also when this vehicle was encountered earlier in the day, the bed of the truck was relatively empty. This truck's bed was now visibly loaded with suitcases, garbage bags, and other miscellaneous items. Due to the fact that this vehicle was registered to an illegal alien who was believed to be driving the Ford F-250 and the fact that there had to be at least five new people in this vehicle, BPA-Intelligence conducted a vehicle stop with the Georgia Plated F-250. Upon approaching the vehicle, BPA-Intelligence identified himself as a Border Patrol Agent and noticed that there were six male subjects inside the vehicle. After a quick glance BPA-Intelligence was also able to confirm that was driving this instructed vehicle. BPA-Intelligence to turn the vehicle off and hand him the keys.
