Dear Mr. Kick:

This is in response to the above referenced Freedom of Information Act (FOIA) request, in which you requested The Federal Bureau of Prisons' (BOP) FOIA request log for 2017.

On July 23, 2018, I wrote, in pertinent part:

"Are you only seeking requests related to individuals or are you seeking all requests other than first party requests? Please note our database does categorize requests as first party or third party. Thus, we would be unable to create a log omitting 'all requests in which an individual is seeking his/her own records or a lawyer is seeking records on an individual client.' Please provide clarification as to what records you seek."

Since BOP never received a response to the request for clarification, and based on the limitations discussed in the July 23, 2018 correspondence, BOP processed a complete log of requests received in 2017. I want to address a few items, which should help clarify some questions or concerns you may have after reading this response letter and reviewing the enclosed records.

- 1. BOP is unable to provide records that require redaction in an Excel or CSV format. Our database saves processed records as pdfs. We attempted to convert the pdf to a searchable spreadsheet outside of the database, but were unable to.
- BOP does not track whether requests are first party requests, and we are unable to discern whether a request is a first party request without individually reviewing each request.
- 3. BOP lacks the capability to determine how many requesters are inmates. The majority of items redacted in the "Organization" column are federal register numbers assigned to inmates. However, not all items are register numbers, and not all inmates' register numbers were entered into the database. As a result, a redaction of information in the organization column does not necessarily mean the requester is an inmate, and the absence of a redaction does not necessarily mean the requester is someone other than an inmate.

4. The log was created in February 2019, and due to the voluminous nature of the records, processing them took a substantial amount of time. As a result, many of the requests listed as open on the log are now closed

In response to your request, 3,686 pages are attached in four different pdf files. Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, each page contains information redacted under exemption b6 (information which would constitute a clearly unwarranted invasion of the personal privacy of third parties).
