

**SECOND AGREEMENT TO RENEW
INTERGOVERNMENTAL AGREEMENT FOR THE
CONSOLIDATION OF THE COMMUNITY-BASED EARLY
CHILDHOOD PROGRAMS**

This Second Agreement to Renew the Intergovernmental Agreement for the Consolidation of the Community-Based Early Childhood Programs ("**Second Renewal Agreement**") is made and entered into as of July 1, 2019 ("**Effective Date**"), by and between the Board of Education of the City of Chicago, a body politic and corporate commonly known as Chicago Public Schools (the "**Board**" or "**CPS**"), and the City of Chicago, a municipal corporation and home rule unit of government under Article VII, Section 6(a) of the 1970 Constitution of the State of Illinois (the "**City**"), acting through its Department of Family and Support Services ("**DFSS**").

RECITALS

WHEREAS, the City and the Board entered into that certain Intergovernmental Agreement for the Consolidation of the Community-Based Early Childhood Programs (the "**Original Agreement**") with a Term commencing on July 1, 2017 and continuing through June 30, 2018; and

WHEREAS, the parties exercised the first option to renew the Original Agreement with a Term commencing July 1, 2018 and continuing through June 30, 2019 (the "**First Renewal Agreement**"). The Original Agreement and First Renewal Agreement shall be collectively referred to herein as the "**Agreement**";

WHEREAS, the parties now desire to exercise the second option to renew as set forth in this Second Renewal Agreement. Any and all capitalized terms in this Second Renewal Agreement shall have the same definition as set forth in the Agreement unless state specifically otherwise; and

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, including but not limited to the Recitals set forth above, which are incorporated into this Agreement by reference, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. **Second Renewal Term:** The Original Agreement is hereby renewed for twelve (12) months, commencing on the Effective Date set forth above and continuing through June 30, 2020 ("**Second Renewal Term**"). In accordance with the authorizing Board Reports, the parties shall have no additional options to renew upon the execution of this Second Renewal Agreement.
2. **Early Childhood Program:** The parties agree that the Early Childhood Program continues to operate as described in the Agreement and that the City shall continue to provide, through its subcontractor community-based organizations, the Services described in the Agreement through the Second Renewal Term.
3. **Grant:** CPS shall continue to grant funds to DFSS for the Services provided pursuant to the terms of the Agreement during the Second Renewal Term in accordance with the terms stated

in the Funding Guidelines that are attached and incorporated into the Original Agreement as Exhibit C. The maximum amount payable to DFSS during the Second Renewal Term shall not exceed Seventy-Two Million Eight Hundred Thousand Dollars (\$72, 800, 00.00), as authorized by Board Report No. 19-0522-EX__, as may be amended. All other terms in the Agreement regarding compensation and payment remain in full force and effect during the Second Renewal Term.

4. **No Other Amendments**: Except as stated herein, all other terms and conditions of the Agreement, including specifically all exhibits incorporated therein, remain in full force and effect during the Second Renewal Term.

5. **Board Approval**: The Execution of this Agreement is subject to approval by the Board of Education of the City of Chicago.
