Requests are processed in the order in which they are received through our multi-track processing system. Requests are divided into two primary tracks--simple (under 50 pages of potentially responsive documents) and complex (over 50 pages of potentially responsive documents). Complex requests are further divided into medium, large, and extra-large sub-tracks based upon request size. Simple track requests typically require the least amount of time to process. Currently, simple track cases average approximately 80 days from the date of receipt for processing. Our complex requests in the large processing track are currently averaging approximately 774 days for processing.

Your request is currently in the complex request large processing track, and the estimated date of completion for your request is November 2019. Reducing the scope of your request can accelerate the process as it could potentially place your request in a quicker processing track. This may also reduce any search and duplication costs, if applicable, and allow for a more timely receipt of your information. The cost letter dated June 20, 2017 indicated 1,518 records had been located which may potentially be responsive to your request. We need written confirmation that you have agreed to any costs associated with the processing of your case. The costs were stated for this number of records to be at \$55.00.

>>> Because your request is considered a large sized case, it was sent to negotiations for us to see if you would consider reducing the size of your request. I've just looked at the records and I believe if only main sections of the file are processed, the more exact number of pages to be reviewed is just under 800 pages. This size would move your request into the medium track queue for processing. The current estimated time for processing a medium sized case is approximately 10 months. There will be an interim release of 500 pages which then is followed by the final release. The other significant difference between the medium and large track queues, is that a large case moves into an unassigned backlog until it can be picked up and worked into an analyst's queue. The processing time for large sized cases is greatly increased over the medium track. In addition, medium sized cases are placed into a direct assign backlog.
