



<p>On the above date and time I was dispatched to [redacted] Bar for a physical fight between two females. Up arrival I observed Ofc. Lentocha escorting a handcuffed female to his cruiser. This female was later identified as Samara [redacted]. I later learned that the handcuffs were placed on [redacted] by [redacted] security due to her unruly and disruptive behavior. As I exited my cruiser, I observed [redacted] become combative with Ofc. Lentocha and Ofc. Estes as they attempted to remove the handcuffs from her wrist. [redacted] was being held over the hood of the police cruiser as an attempt to control her. As this was happening I observed [redacted] make an aggressive backward kicking motion striking Ofc. Lentocha in the leg. She was then placed in police handcuffs and put in the back of a police cruiser. Please refer to Ofc. Lentocha's supplemental report for further detail.</p> <p>I met with [redacted] security personnel who was identified as Jessica [redacted]. [redacted] stated numerous bar patrons approached her and other [redacted] employees about an intoxicated female who was attempting to engage in a physical altercation with any willing participants. [redacted] stated she and other security personnel approached [redacted] and advised her she had to leave. [redacted] stated [redacted] initially cooperated until they escorted her outside where she became physically combative with her, other security members and bar patrons. As a result [redacted] was placed in handcuffs and the police were called. [redacted] stated after [redacted] was placed in handcuffs, [redacted] made numerous attempts to kick her. [redacted] stated she was able to avoid most attempts however she was kicked in the lower stomach area by [redacted]. [redacted] declined medical treatment stating the pain she felt was only temporary. The kick that [redacted] suffered was observed by Ofc. Lentocha as he arrived.</p> <p>Based on the aforementioned facts, [redacted] was taken into custody and transported by Ofc. Lentocha to EHPD for processing. While at headquarters, [redacted] was provided with the opportunity to rinse her face of the OC spray that was used to subdue her. At EHPD [redacted] was belligerent and</p>


appeared intoxicated. When [redacted] was asked routine processing questions she would respond with comments such as "Fuck you bitch as nigga cracker", " Suck yo daddys cock and choke on it you bald headed cracker".

Also note that according to [redacted], due to the over powering effect of the pepper spray, she was unable to sign her Miranda warnings or her property form. [redacted] did acknowledge her Miranda Warnings and stated she understood them.

Feliciano was charged with the following: 53a-182: Disorderly conduct, 53a-167c: Assault on a police officer and 53-37: Racial Ridicule. [redacted] is being held on a \$5,000 surety bond.
