A joint fact finding board committee meeting will be held with all stakeholders including the public, NYC DOT, NYPD, Traffic Enforcement and the FDNY. This meeting will be followed by a separate Public Hearing to listen and engage with any NYC DOT formal solutions to those concerns that came out of the fact finding meeting. Hi Gale,

This DOT workshop for traffic calming / bike lanes on central Dyckman St was supposed to be last fall. They've given us 3 days notice and it's only those who happen to get it by private emails via Martin Collins. They're designing this to be so that almost nobody knows about it. The fact that they are "Once Again showing its proposal" means they haven't changed a thing and going through the motions here. They presented the same thing at two CB12 T&T meetings last year and were rejected both times by the committee and the likes of me for suggesting painting green lanes next to the existing parking lanes. This is invitation to keep double-parking and maintain the status quo of 4 parking lanes and 2 travel lanes for Dyckman.

Why is it that my initial presentation was Feb. 2008, and CB12 had resolutions starting in 2010, and it's now 2017 and we're still nowhere? I even had a longish meeting last year with Ydanis who seems to like a lot of the ideas I presented for traffic calming (along the lines of Denver's downtown thoroughfare (see attached ppt). Can your office help? I'm attaching the original handout given to CB12 T&T in Feb. 2008, based on the separated bike lane on 9<sup>th</sup> avenue but with more greenery.
