The Los Angeles County District Attorney's Office is in receipt of your California Public Records Act request dated January 6, 2020, wherein you requested "Documents describing incidents, statistics, or concerns about 'juice jacking,' the practice of using cell phone charging as a cyberattack vector, produced since January 1, 2019."

I have searched our records and found no public documents responsive to your request. Please understand that we treat all complaints as confidential. Accordingly, we do not disclose the names of complainants, records of complaints or our investigative files to the public. Pursuant to California Government Code section 6254(f), law enforcement investigative files and records contained therein, including police reports, witness statements, records of complaints, letters received and sent, evidence collected, official information acquired in confidence, and documents provided to our office by a governmental agency which we agreed to treat as confidential, are all exempt from disclosure. (See also Government Code sections 6254(k) and 6255; Evidence Code sections 1040 and 1041; Penal Code section 1054.6; Rackauckas v. Superior Court (2002) 104 Cal.App.4th 169, 176-177; and City of San Jose v. Superior Court (1999) 74 Cal.App.4th 1008).
