## To Whom It May Concern

This is written on behalf of 47 detainees in I.C.E detention at Bristol County Detention Center, North Dartmouth, MA we are already sufferring being away from our loved ones & families. We are not prisoners or Inmates, many of us here have not committed any aggravated criminal offenses and some are in the United States for the first time in our lives. We fairly believe we should not be subject to the same or in some cases even worse forms of punishments as Convicted Felons/Prisoners.

- 1). On March 13, 2020 Bristol County correctional officers informed us that we had 24 hours to see our family. Although not contact, the visits would be suspended for 2 weeks in regards to the Corona Virus. Most of our families live out of state or atleast a 1-3 hour drive from Bristol County. This was so abrupt and short notice that many of our families could not meet the deadline. We find the lack of time given to notify our families very unfair and inhumane. The facility explained that our visits were cancelled in order to contain the virus from entering the building and for the safety of the detainees. This unlogical reason is contradited by ICE as though new detainees are being admitted in to the facility directly from the street. Last night a detainee was brought from the street without going through basic intake. They were taken 12 hours later to intake for biometrics and medical check up.
- 2). Although the FCC has announced that no more than 10 peoples should be in any room together at the same time. Currently there are 47 people in just this unit (ICE-A). There are also 57 people in ICE-B a unit that is located only a couple feet away on the other side of this building. The room we are kept in is roughly 3500 square feet of open space except for the bunk beds which are bairly 3 feet apart from each other. We have a dining room which is not separated rather is visible from the beds. We have round plastic party tables, and when they are set up for meal time they are only seperated inches from each other. All 47 inmates eat at the same exact time which makes the dining area very crowded. We have batrhoom stalls and showers (many of which are growing mold). We have one small room set up for Movies, Computer access, and also Church. This room is occupied by all detainees and does not have ventilation. Many times the room gets heated/musty by our body heat and breath alone.
- 3). We recently listened to the Bristol County Sherrif's television message in regards to how the detainees are going to recieve new changes to keep the sanitation and to keep COVID-19 virus from spreading. One of these changes was explained that we would be seperated and kept at a minimum 6 feet distance from each other in order to contain the possible spread of the COVID-19 virus. We are still being kept in the same room for weeks now with no separation or distancing. To add on to this the FCC is informing and advising all business and government facilities to have no more than 10 people in one room at a time. We have 47 detainees in this unit alone (ICE-A). New detainees are being brought in **directly** from the street daily.
- **4).** Although we are only being detained for immigration purposes, we are all suffering the same punishments that Convicted felons or prisoners recieve. Many of us here **have not** committed any aggravated criminal offenses and some are in the United States for the first time in our lives. We suffer from being seperated from our families and loved ones. To add on top of this, we are now living in fear for our lifes because more detainees are being brought in directly from the street everyday, without being quarantined first.

## Please help. We fear for our safety.
