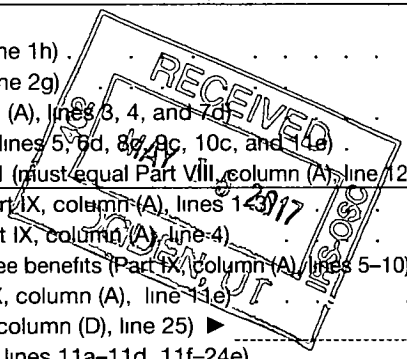

2016 Revenue includes income resulting from the acceptance by the 1851 Center for Constitutional Law of attorneys fees ordered by courts to be paid by opposing governmental actors in case(s) of broad public importance where a private law firm did not and would not act.

Most prominently, the fees listed are derived from class action litigation stretching from 2010 to

2017 declaring a property tax to be unconstitutional and ordering the return of \$5.5 million in illegal taxes to the community's taxpayers.

The possibility of the aforementioned attorneys fees award(s) in no way influenced the 1851 Center's decision to initiate litigation.

The 1851 Center did not believe that any opportunity for a fee award existed when it began litigating *Sanborn v. Hamilton County Budget Commission* in 2010.

No 1851 Center client paid any attorney fee to the 1851 Center. No 1851 Center client has ever paid a fee for services to the 1851 Center in any 1851 Center case.

The amount of court-awarded attorneys fees is unusually large and unexpected. It is not representative of a business model, and the 1851 Center does not expect to receive any similarly-large awards of attorneys fees in the near future. This amount is related to a case that involved approximately six years of focused litigation on behalf of an entire school district's taxpayers.

Attorneys fees awards are always paid to the organization, never to the staff, and staff never earns a commission of any kind on such awards.

*Of note, in the case mentioned above, the Indian Hill Exempted Village School District mistakenly sent a 1099 for \$900,000 to the 1851 Center. However, only \$688,000 of this amount represented attorneys fees owed via court order to the 1851 Center. The remaining balance, \$212,000, properly belonged to citizens and clients in the community at issue, and to outside attorneys who also assisted on the case. The 1851 Center informed IHEVSD of this mistake; however, IHEVSD declined to issue a corrected 1099.
