Good afternoon Mr. Westervelt,

This is 1st Marine Division's final response to your request under the Freedom of Information Act (FOIA). Please be advised that after diligent searches, no responsive records were located.

We recognize your fee category as "media"; therefore, search, review, and the first 100 pages of duplication are free of charge. Duplication costs are \$0.15 per page. You set a Fee Limit of \$200; however, no fees will be charged by this command as no records were found. Your fee waiver was deemed "Not Billable".

This does not constitute a denial of records as no records were found by

this command; however, I am advising you of your right to appeal this determination to: Judge Advocate General of the Navy (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal, if any, must be postmarked within 90 calendar days from the date of this letter and should include a copy of your initial request, a copy of this letter, and a statement indicating why you believe your appeal should be granted. I recommend that your appeal and its envelope both bear the notation "Freedom of Information Act Appeal."
