Dear Mr. Evers:

This letter partially responds to your September 4, 2019 Freedom of Information Act (“FOIA”) request to the Office of Legal Counsel (“OLC”) and others seeking “email communications . . . sent by the [listed] officials . . . containing any of the [listed] key terms.” As you know, the request was assigned the tracking number FY19-211, is also the subject of the above-captioned litigation, and has been narrowed in certain ways by negotiation through counsel.

OLC has completed a search of its records and as agreed through counsel, OLC has processed a portion of the identified responsive records. To date OLC has processed 115 records totaling 3,216 pages. We have withheld in full all 115 records pursuant to FOIA Exemption Five, 5 U.S.C. § 552(b)(5). For your information, Exemption Five exempts material protected by the attorney-client, deliberative process, and presidential communications privileges, as well as the attorney work product doctrine and other privileges. We have determined that none of the withheld material is appropriate for discretionary release. We are continuing to process responsive records.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

This letter partially responds to your September 4, 2019 Freedom of Information Act ("FOIA") request to the Office of Legal Counsel ("OLC") and others seeking "email communications . . . sent by the [listed] officials . . . containing any of the [listed] key terms." As you know, the request was assigned the tracking number FY19-211, is also the subject of the above-captioned litigation, and has been narrowed in certain ways by negotiation through counsel.

OLC has completed a search of its records and, as agreed through counsel, OLC has processed a portion of the identified responsive records. Since the last letter in this matter, OLC has processed 68 records totaling 532 pages.

We have referred 32 records totaling 312 pages to two other entities for direct response to you. We have withheld in full the remaining 36 records totaling 222 pages, pursuant to FOIA Exemption Five, 5 U.S.C. § 552(b)(5). For your information, Exemption Five exempts material protected by the attorney-client, deliberative process, and presidential communications privileges, as well as the attorney work product doctrine and other privileges. We have determined that none of the withheld material is appropriate for discretionary release. We are continuing to process responsive records.
