A RESOLUTION ESTABLISHING A GOAL OF ONE HUNDRED PERCENT (100%) CLEAN ENERGY FOR THE VILLAGE OF BRATENAHL FACILITIES BY 2025 AND FOR THE COMMUNITY AT LARGE BY 2035 AND DECLARING AN EMERGENCY

WHEREAS, 139 U.S. cities, including Cleveland and Cincinnati, have already adopted ambitious 100% clean energy goals, and six U.S. cities have already hit their targets to generate 100% of the energy used community-wide from clean, non-polluting and renewable sources; and

WHEREAS, "renewable energy" includes energy derived from wind, solar, existing and low impact hydroelectric geothermal, biogas, and wave technology sources; and

WHEREAS, Bratenahl's commitment to 100% clean energy will create good local jobs, reduce air pollution and other health risks, and save consumers money; and

WHEREAS, Bratenahl has already made progress towards this goal by studying ways to reduce energy consumption and increase efficiency; and

WHEREAS, renewable energy now offers greater economic security, lower electricity costs, and a more affordable energy solution for individual consumers than ever before.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. The Council does hereby commit to a goal of one hundred percent (100%) clean energy for the Village of Bratenahl facilities by 2025 and for the community at large by 2035.

SECTION 2. The Council does hereby direct the administration develop a plan during FY 2020 that lays out a roadmap for the Village of Bratenahl to achieve these ambitious goals and to proactively seek input from the community in developing this plan.

SECTION 3. The Council will prioritize the lowest cost measures to meet energy needs to be mindful of the use of taxpayer dollars and any impact of consumers' personal expenses.

SECTION 4. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the inhabitants of the Village of Bratenahl by reason of the Council's desire to establish a goal regarding clean energy; wherefore, this Resolution shall be in full force and effect from and immediately after its adoption. The Mayor is authorized to extend the Professional Services Agreement/Contract with the Cleveland Restoration Society to provide eligible Village homeowners with the ability to participate in the Heritage Home Program with management fees not to exceed eight hundred dollars (\$800.00) for the 2020 calendar year.

WHEREAS, each member community pays a startup fee of \$5,000.000 and thereafter an annual fee using a comprehensive formula whereby the costs are shared equitably; and

WHEREAS, the Bratenahl Police Chief has requested that the Village join the EDGE TEAM.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Bratenahl, County of Cuyahoga, State of Ohio, that:

SECTION 1. The Police Chief be, and he hereby is, authorized to join Eastside Departments Group Enforcement (EDGE) on behalf of the Village and to execute all necessary documents to do so.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the inhabitants of the Village of Bratenahl by reason of the immediate necessity to join EDGE; wherefore, this Resolution shall be in full force and effect from and immediately after its adoption.

AN ORDINANCE AMENDING SECTION 121.03 OF THE ADMINISTRATIVE CODE TO CHANGE THE TIME OF COUNCIL MEETINGS AND REVISE THE ORDER OF BUSINESS AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. Section 121.03 of the Administrative Code be amended to read as follows:

"121.03 MEETINGS.

- (a) Regular meeting of Council shall be held in the Council Chamber of the Village Hall or at another location in the Village at 5:30 p.m. 6:30 p.m. on the third Wednesday of each month.
- (b) The Mayor, or any three members of the Council may call special meetings upon at least twenty-four (24) hours' notice to each member, served personally or left at their usual place of residence, and email.
- (c) A quorum is a majority of the elected members to Council. In the case of a vacancy in the Council membership, a quorum of the remaining members constitutes a quorum.
  - (d) The roll call of Council shall be in alphabetical order.
  - (e) Business of all regular meetings of the Council shall be transacted in the following order: Call to order

Pledge of Allegiance

Approval of Council minutes

Mayor's Court report

#### Mayor's report

Clerk's report of fund balances Fiscal Officer's report

Correspondence

Committee reports Boards and Commissions Reports

Old/new business:

Adjournment.

- (f) Responsibility for preparation of the agenda for each meeting of Council shall be vested in the President of Council, in consultation with the Chairpersons of the Committees of Council, and the Clerk.
- (g) All meetings of the Council shall be open to the public, unless an executive session is expressly authorized under Ohio Revised Code Section 121.22(G).
- (h) The Ohio Revised Code, the Codified Ordinances of the Village of Bratenahl, including Chapters 127, Code of Conduct, and 129, Code of Ethics, the Ohio Ethics Law, and, if none of the aforementioned laws are applicable, then Robert's Rules of Order as revised from time to time, shall govern all proceedings of the Bratenahl Village Council and its Committees and it shall be the duty of the presiding officer or chairperson thereof to adhere to and enforce such rules.
  - (i) Citizen/public participation:
    - (1) Any citizen may appear and be heard at a public meeting of the Council.
- (2) For Council meetings, the President of Council may recognize any member of the public for the purpose of addressing the Council on any matter on which Council action is required. In such cases, the person recognized shall address the Chair, state his/her name and address, and the subject matter he or she desires to discuss. Remarks must be confined to the merits of the subject at issue.
- (3) For Council Committee meetings, the Chairperson may recognize any non-member for the purpose of addressing the Committee on any question or any matter on which Committee action is required. In such cases, the person recognized shall address the Chair, state his/her name and address, and the subject matter he or she desires to discuss. Remarks must be confined to the merits of the subject at issue.
  - (4) Speakers must be courteous and avoid discussion of personalities.
  - (5) Speakers must limit their remarks to three (3) minutes.
- (6) Speakers must adhere to the provisions set forth in Section 129.05, Conduct at Village Meetings, of the Codified Ordinances."

SECTION 2. The Section 121.03 of the Administrative Code as it existed prior to the effective date of this Ordinance and all other ordinances and resolutions inconsistent with, be, and the same hereby are, repealed.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village of Bratenahl and for the further reason that there is a necessity to change the time of council meetings and revise the order of business; therefore, provided this Ordinance receives two-thirds vote of all members of the Council elected thereto, it shall be in full force and effect from and after the earliest time allowed by law.

# AN ORDINANCE AMENDING SECTION 121.08 OF THE ADMINISTRATIVE CODE TO REMOVE LEGISLATION COMMITTEE AND REVISE RECORDING OF MINUTES AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. Section 121.08 of the Administrative Code be amended to read as follows:

### "121.08 COMMITTEES OF COUNCIL.

- (a) At the first meeting of the Council in January of each even-numbered year, or as soon thereafter as may be practicable, the Mayor shall appoint, after consultation and mutual agreement, three (3) Members of Council to establish the following standing Council Committees and who shall serve for a period of two (2) years. The Mayor shall then choose one (1) person so appointed to act as chairperson for the Committee thereof. Such Council Committees shall be as follows:
  - (1) <u>Finance</u>: May consider and recommend on the budget, assessments, taxes, fees, transfer of property to or from the Village, and other financial matters.
  - (2) <u>Legislation</u>: May consider and recommend on such matters as Village Planning Commission recommendations, the Planning and Zoning Code, and selected administrative issues including ordinances and resolutions.
  - <u>Public Improvements</u>: May consider and recommend on such matters as the water supply, water and air pollution, sewers, trash disposal and the maintenance and repair of public property, and issues regarding building and housing.
  - <u>Public Safety:</u> May consider and recommend on such matters as public health, police, fire, traffic, streetlights, use of public thoroughfares, and safety issues related to building and housing.
  - Master Plan: May consider and recommend on such matters identified in the Strategic Master Plan dated December 2013 and its recommendations and milestones, and amendments
  - (5) Committee of the Whole: May consider any matter appropriate for Council with the President of Council to preside at such Committee meeting.
  - <u>Committee of the Whole:</u> May consider any matter appropriate for Council with the President of Council to preside at such Committee meeting.
  - (7) Additional Authorized Committees: Council may authorize any other committee deemed necessary.

AN ORDINANCE AMENDING SECTION 1121.01
OF THE PLANNING AND ZONING CODE TO REVISE
MEMBERSHIP ON THE BOARD OF ZONING
APPEALS AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. Section 1121.01 of the Planning and Zoning Code be amended to read as follows:

## "1121.01 MEMBERSHIP; TERM

- (a) There is established the Board of Zoning Appeals of three members, consisting of the Mayor, President Pro Tempore of Council a Council member representative to be appointed by the Council and a resident freeholder appointed by the Mayor and approved by Council prior to the effectiveness of the appointment for a term consisting of two years commencing on January 1 of the even numbered years, but who shall initially be appointed for a term ending December 31, 1963.
- (b) There shall be appointed two alternate members who are resident freeholders appointed by the Mayor and approved by Council. In the event a regular member is absent for any reason or has a conflict of interest with respect to a proposed project under review, an alternate member shall be designated by the Chairman of the Board to serve during such absence or such conflict of interest. When serving in the place of a regular member of the Board, an alternate member shall have the same powers and perform the same duties as a regular member of the Board."

SECTION 2. Unless specifically amended herein, Section 1121.01 of the Planning and Zoning Code as it existed prior to the effective date of this Ordinance shall remain in full force and effect.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village of Bratenahl by reason of the immediate necessity to revise membership on the Board of Zoning Appeals; therefore, provided this Ordinance receives two-thirds vote of all members of the Council elected thereto, it shall be in full force and effect immediately after its passage.
