NEIGHBOR TROUBLE. UPON ARRIVAL, WE MET WITH DEBRA POULSEN WHO TOLD US THAT HER NEIGHBOR'S (2318-WASH) SON, DUSTIN, HAD (2) FRIEND'S VEHICLES OVER AT HIS HOUSE AND THEY WERE REVVING THEIR ENGINES VERY LOUDLY. DEBRA TOLD US THAT SHE HAS BEEN HAVING ON-GOING ISSUES WITH THE NEIGHBORS FOR THE LAST 3 YEARS - ALL RELATED TO LOUD AND UNNECESSARY NOISE THAT WAS DISRUPTIVE. DEBRA TOLD US USUALLY THE NEIGHBORS ARE REVVING THEIR VEHICLES, PLAYING LOUD MUSIC, OR RUNNING AN OLDER ATV THAT IS VERY LOUD. WE SPOKE TO DEBRA'S NEIGHBOR DUSTIN.
