**INFORMATION ABOUT THE INCIDENT**

**Description of the incident :** ON THE MORNING OF MARCH 28, 2013 (APPROX 0730 AM) THE NARCOTICS DIVISION OF CPD ABRUPTLY AND WITHOUT WARNING AGGRESSIVELY ENTERED OUR HOME AT [REDACTED] OUR BACK DOOR WAS FRAGMENTED WITH A FORCE TO OVERCOME THAT OF A DEAD BOLT AND PROTECTIVE DOOR ROD. LOUDLY, A DIVISION OF ARMED OFFICERS CLEARED THE HOME, PRIOR TO ANNOUNCING THEIR INTENTIONS. THE SEARCH WARRANT WAS FOR A COMPLETELY DIFFERENT ADDRESS, AND INTENDED RECIPIENT. FIRST AND FOREMOST, MY TWO SMALL CHILDREN (1 YEAR OLD AND 3 YEAR OLD) HAVE SUBSEQUENTLY SUFFERED FROM HYPERSENSITIVITY TO ALL SOUNDS. DAY AND NIGHT ROUTINES HAVE BEEN DISRUPTED, AND ARE WITHOUT RESOLUTION, EVEN ALMOST 3 WEEKS AFTER THE INCIDENT. FURTHERMORE, I SUFFERED MENTAL AND EMOTIONAL TORMENT AND DISTRESS THROUGHOUT THE INCIDENT. ON THAT MORNING, I WAS HALF DRESSED AND IN EVENING ATTIRE WHEN THE GROUP OF ARMED OFFICERS FORCEFULLY ENTERED MY HOME AND ROOM. CLEARLY, THIS WAS A SHOCK THAT I INITIALLY TRIED TO OVERCOME FOR MY CHILDREN, BUT HAS PROVEN TO BE OVERBEARING. BECAUSE OF THIS INCIDENT I LONGER FEEL SAFE IN A HOME THAT WE OWN THAT I HAVE LIVED IN FOR OVER HALF A DECADE. IT HAS GOTTEN TO THE POINT WHERE WE ARE ACTIVELY SEARCHING FOR A NEW HOME. FINALLY, MY HUSBAND A SURGICAL PHYSICIAN AT A LOCAL HOSPITAL IS NOW UNEASY EVERY MORNING ABOUT GOING TO WORK, AND SPENDING EXTENDED HOURS AWAY FROM FAMILY GIVEN THESE UNSAFE CIRCUMSTANCES. IN SUMMARY, ALTHOUGH THE INTENTIONS OF CURBING DRUG ACTIVITY IN THE NEIGHBORHOOD WERE ADMIRABLE, THERE ARE CLEARLY MISTAKES THAT WERE MADE. THESE MISTAKES HAVE

DISRUPTED OUR DAILY LIVING ROUTINES AND HAVE CAUSED NOT JUST PHYSICAL DAMAGE TO OUR HOME, BUT EXTENDED EMOTIONAL DISTRESS. WE NO LONGER FEEL SAFE NOT JUST OUR HOME, BUT ALSO IN OUR NEIGHBORHOOD. MISTAKES OBVIOUSLY HAPPEN, BUT IN THIS CASE THERE IS CLEAR EVIDENCE THAT ACCURATE RESEARCH WAS NOT OBTAINED BY THE AUTHORITIES INVOLVED, DISPLAYING RECKLESSNESS ON BEHALF OF THE CITY OF CHICAGO.
