There I believe the explanation appears in the next line in the list, i.e. the published memo linked below corresponds with "30. General Counsel/OMB: Revised Memorandum re Authority of Chief Financial Officer under FY 2003 HUD Appropriations (Whelan) August 12, 2003." I have not attempted to determine whether the August 8 version was finalized, signed, or transmitted to a client, nor have I attempted to determine whether or to what extent the documents differ.

Here, for this and any other discrepancies you may find as you continue reviewing the records, I think it's worth repeating the caveat from the FOIA reading room on the prior productions: while these lists are occasionally identified as responsive to FOIA requests and processed as such, they are created for internal tracking purposes and are not intended for public consumption as perfect and comprehensive lists of all OLC opinions.

I've discovered another dating discrepancy that I'm hoping you can again shed some light on.

In your recent production, there is an August 8, 2003 memo entitled:

29. General Counsel/OMB: Memorandum re Authority of Chief Financial Officer under FY 2003 HUD Appropriations (Whelan) August 8, 2003

There also appears to be a memo with the same title and author in the official OLC database, but with a date of August 12, instead of August 8. (https://www.justice.gov/file/18971/download).

Are these two entries referring to the same document or to two different documents on the same subject?

Hello Daniel, you're welcome. In general, I believe any differences between the old and new productions mean that at some point between the last time the documents were processed and now, someone noticed an error (or a perceived error) and made a correction. With respect to the specific entries you note:

1. 2007 Memo to DOD – this appears to be a corrected date; see the actual published version at https://www.justice.gov/file/451166/download with the correct date

2. 2007 Memo to OJP – this has also been adjusted to the correct date, see https://www.justice.gov/file/ 451561/download

3. 2010 Testimony re USVI – for this one, both dates appear to be correct. DAAG Cedarbaum submitted the same prepared statement twice, once on March 17, 2010 to a subcommittee of the House Committee on Natural Resources, https://www.justice.gov/sites/default/files/testimonies/witnesses/attachments/2010/03/ 17/2010-03-17-olc-cedarbaum-virgin-islands.pdf, and once on May 19, 2010 to the Senate Committee on Energy and Natural Resources, see https://www.govinfo.gov/content/pkg/CHRG-111shrg61779/pdf/CHRG-111shrg61779.pdf, starting at page 52.

4. 2015 Testimony re Draft VA legislation – both dates appear on the face of the underlying document, for which I was unable to locate a public version. Although we have not attempted to verify this, the document indicates that the statement was prepared to be submitted for the record of a hearing scheduled for April 23, 2015, but was actually dated for submission on July 20, 2015.

Thank you for providing the responsive documents.

dated June 29, 2007 [new production]


