# PETITION FOR DAMAGES EMOTIONAL DISTRESS

NOW INTO COURT, through undersigned counsel, comes plaintiff, Brian Gibson, a person of the full age of majority and domiciled in the Parish of Orleans, State of Louisiana, who respectfully asserts as follows:

I.

Made defendants herein are:

- New Beginnings Schools Foundation, (herein after NBSF), is a non-profit corporation registered in, and authorized to do, and doing business in the State of Louisiana, Parish of Orleans
- 2. Runell J. King, a person believed to be of the full age of majority and domiciled in the State of Louisiana, Parish of East Baton Rouge.

II.

On or about May 24, 2019 Plaintiff Brian Gibson, while serving as Principal of John F. Kennedy High School at Lake Area received correspondence from Michael L. Washington, Director of Human Resources for NBSF, terminating his employment with New Beginnings Schools Foundation (attached exhibit 1). Principal Gibson's school assignment with NBSF began on July 9, 2018 extending until the end of the NBSF 2018-2019 academic calendar school year (attached exhibit 2 offer letter). During said term Principal Gibson was to receive total compensation from NBSF in the cash amount of one hundred eighteen thousand five hundred and sixt of the letter.

administration leader. Principal Gibson has received many awards and accolades for his performances in those various jobs.

III.

Pursuant to NBSF'S employee handbook Principal Gibson performed all duties incumbent upon him faithfully and efficiently. Additionally, Principal Gibson abided by all of the laws of the State of Louisiana, rules and regulations of the State Board of Elementary and Secondary Education, State Department of Education, New Beginnings Schools Foundation Board, New Beginnings Schools CEO.

IV.

On or about February 1, 2019 defendant, Runell J King orchestrated and alleged an improper/inaccurate grade adjustment scheme at John F. Kennedy High School at Lake Area. Carelessly, recklessly and in bad faith implicating Principal Gibson and the leadership team prior to proper due diligence or proper investigation. At all times material herein defendants NBSF and King knew or had reason to know that Principal Gibson had no knowledge or role whether actual or attributable to any alleged improper grade adjustments.

V.

Defendant King's allegations caused NBSF and Orleans Parish School Board to Launch two (2) separate investigations into said allegations of improper conduct. Both investigations were concluded with no findings to substantiate King's baseless allegations. In fact, King was disciplined by NBSF for failure to provide accurate or truthful data to support his allegation of improper grade adjustments.

WHEREFORE, plaintiff prays that the Petition for Damages for Emotional Distress be filed, that defendants, NEW BEGINNINGS SCHOOLS FOUNDATION AND RUNELL J. KING, be duly cited and served with a certified copy of same, and that after due proceedings are had herein that there be judgment in favor of plaintiff and against defendants, jointly, severally, and in solido for any and all damages sustained by plaintiff, Brian Gibson, with legal interest, from the date of judicial demand and for all attorney's fees and costs of these proceedings. Plaintiffs further prays for all general and equitable relief to include compensatory and consequential damages.

Dear Mr. Gibson:

As you are aware, NBSF leadership requested an investigation into several allegations made against John F. Kennedy High School at Lake Area. Those allegations included, but were not limited to, the allegation of improper/inaccurate grade adjustments.

During the investigation, it became clear that you engaged in activities that violated your duties to the students and violated school policies and procedures as it relates to grading and grade adjustments. Accordingly, effective May 24, 2019, you are terminated from your employment with New Beginnings Schools Foundation. Your final paycheck will be provided in the delays allowed by law. That paycheck will include any and all amounts due to you per NBSF policy.

Your health insurance coverage will be effective until May 31, 2019, if you have elected coverage. Please be advised that you and your eligible dependents may continue participation in the organization's group medical and dental plans through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Please contact Human Resources for more information. You should also receive information in the mail regarding your coverage. Please note, there are deadlines to opt into Cobra coverage. Immediate review and acceptance of your Cobra benefits will ensure that you retain your eligibility.

Additionally, you are required to immediately return all of the school's property obtained during your employment including, but not limited to, tangible property (which includes computers, identification badges and keys) and any materials of any kind that contain or embody any proprietary or confidential information of the New Beginnings Schools Foundation and/or JFK High School at Lake Area. These items are to be turned in to Michael Washington, the Director of Human Resources immediately or no later than the close of business, Tuesday, May 28, 2019.
