Because we will need to search for and collect requested records from field facilities or other establishments that are separate from the office processing the request, we are taking a 10-workday extension under 43 C.F.R. § 2.19. For the same reason, we are placing your request under the "Normal" processing track. See 43 C.F.R. § 2.15.
