DHS-OIG conducts independent investigations, audits, inspections, and special reviews of DHS personnel, programs, and operations to detect and deter waste, fraud, and abuse, and to promote integrity, economy, and efficiency within DHS. Please note that the I-730 is a U.S. Citizenship and Immigration Services (USCIS) form that is administered by USCIS; therefore, DHS OIG would not maintain the type of records you have requested.

Appeal
