Contributions to Georgians for Kelly Loeffler are not deductible as charitable contributions for federal income tax purposes. An individual may contribute up to \$2,800 for the general election and up to \$2,800 designated for the general run-off election. Federal multicandidate PACs may contribute up to \$5,000 for each election. Contributions from corporations, labor unions, federal-government contractors, national banks, and foreign nationals who are not lawfully admitted for permanent residence are prohibited. Federal law requires Georgians for Kelly Loeffler to use best efforts to report the name, mailing address, occupation, and employer of persons whose contributions aggregate in excess of \$200 in an election cycle.
