Also - in noting the decreased grant amount/total grant size this year, Charisse and I wanted to bring something to your attention. Last week I received a call from Camille Green, a probation officer, regarding one of her offender's payments to DMMF. She said that in plea agreements written by the SAO, it says where to make the payment, however – all the payments she has personally seen are payable to Kristi House, *not* DMMF. Perhaps this issue warrants a conversation with Advocate Program, the POs, or Kristi House?
