Brian,

Mike mentioned that he discussed with you that we are looking for our CEO Annette Clayton to meet with Secretary Perry. Schneider Electric is a global energy management and process automation leader, with 20,000 employees in the US and 22 manufacturing facilities, and presence in every state. Annette met the Secretary at CERA week, I believe, as we are a large oil and gas supplier. We have extensive facilities in Texas. We are also a supplier to the entire utility sector, from coal, gas, to nuclear to renewables. 72% of world's buildings have some kind of Schneider equipment in them, including the White House and the Pentagon.

Right now we are heavily engaged in installing microgrids. I believe the Secretary

met with Quanta to discuss Puerto Rico, a potential partner for us. Navigant Research has named us #1 installer for US microgrids, and we have a few solutions to offer for disaster relief. We can provide immediate assistance with smart inverters and islanding old substations, but also rebuild in a more resilient manner. We also have three existing federal facility projects there that are under Energy Savings Performance Contracts, and we'd like to rebuild them for resilience. We are looking for a public-private partnership in this situation, with some private funding that we can raise, as we usually do, and some federal funding. I understand Stafford Act is making it a challenge to rebuild with upgrades and resilience in mind, but we'd like to discuss all this with the Secretary in addition to a broader conversation about our work with an agency. We are spending a lot of time with the Advanced Manufacturing Office on digital manufacturing, for example, and energy savings through process automation. Nuclear cleanup, and a few other things in the energy management space.

I am sure his schedule is a challenge, but we can meet him in DC, in Texas (Houston and Dallas are our big hubs there), and in our headquarters and R&D center in Andover, MA just outside of Boston. The headquarters also have a newly installed microgrid, if he'd like to see one in action.

Please, let me know how we can proceed finding a suitable time and location.

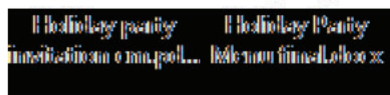

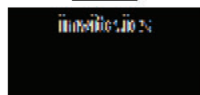
