This letter is in response to your 2 March 2020 Freedom of Information Act (FOIA) request on behalf of Mr. Hall for information regarding “the appointment letters and resumes of all the current members of the Physical Disability Board of Review,” and “documents showing the civilian and military status of Dr. Dan Malone of the PDBR as well as his appointment letter to the Board and resume.”

In response to your request, the Air Force for Manpower and Reserve Affairs directorate conducted a thorough and appropriate search for responsive information relating to your request and located four documents responsive to your request. After our line-by-line review of the records, we have made the following determinations regarding releasability:

- Three documents are provided contain information which if released, would constitute a clearly unwarranted invasion of the personal privacy of individuals and is withheld under 5 U.S.C. § 552 (b)(6).
- One documents are withheld in their entirety as they contain information related to the internal personnel rules and practices of the DoD and its components, specifically, information regarding conditions of employment in federal agencies such as matters of hiring and firing and is withheld under 5 U.S.C. § 552 (b)(2).


Should you decide that an appeal to this decision is necessary, you must write to the Secretary of the Air Force, Thru: SAF/AAII (FOIA), 1000 Air Force Pentagon, Washington, DC 20330-

1000 within 90 calendar days from the date of this letter. Include in the appeal, your reasons for reconsideration, and attach a copy of this letter.
