Initial Complaint Narrative

On September 9, 2019, [REDACTED] phens filed this complaint via the CCRB's call processing system:

On September 3, 2019, at approximately 2:05 p m., [REDACTED] was arrested by PO1, PO2, and PO3 in the vicinity of [REDACTED] in the Bronx. [REDACTED] alleged that the officers used excessive force while arresting him, resulting in an scrapes to his knees and leg, numbness to his arm, and a back injury. [REDACTED] received x-rays of his arm at Jacobi Hospital. PO1, PO2, and PO3 were traveling in an unmarked vehicle.

PO1: Hispanic man, bald, dressed in plainclothes

PO2: white man, short, thick build, dressed in plainclothes

PO3: man, tall, slim build, dressed in plainclothes

On September 11, 2019, the CCRB received a duplicate of this complaint from IAB, which was reported by Det. Jeremiah Williams. Det. Williams reported as follows:

On September 3, 2019, at approximately 2:20 p m., Det. Williams, Sgt. Florio, and PO Skender stopped [REDACTED] near [REDACTED] in the Bronx for possession of narcotics. When the officers approached [REDACTED], a struggle ensued and [REDACTED], attempted to take a bag, which was filled with narcotics and currency, from one of the officers [REDACTED] was pushed back and [REDACTED] was placed under arrest. Additional units were called to the scene because there were numerous individuals at the location.

[REDACTED] was transported to Jacobi Hospital for medical attention after he alleged that the officers broke his right hand. [REDACTED] also complained of pain to his right arm and feet. [REDACTED] alleged that Det. Williams placed his finger inside his anus while he was searched inside a prisoner holding cell at the stationhouse.

[REDACTED] was not arrested at the incident location, but she went to the 47th Precinct stationhouse approximately one hour later and was placed under arrest for obstructing governmental administration and inciting a riot [REDACTED] alleged that a "fat white" officer touched her breast over her clothing during the incident.

On September 13, 2019, the CCRB received a duplicate of this complaint from IAB, which was filed by [REDACTED]:

[REDACTED] reported that she witnessed her brother, [REDACTED], be arrested by Det. Williams and another officer. [REDACTED] stated that Det. Williams had his hand on [REDACTED] throat and the other officer placed his knees against [REDACTED]' back. Det. Williams pushed [REDACTED] and ordered her to get back. [REDACTED] denied that she did anything to interfere with the arrest.

[REDACTED], went to the 47th Precinct stationhouse to make a complaint about the incident and was arrested by Det. Williams.
