## Initial Complaint Narrative

---

On September 10, 2007 at approximately 4:30pm, [REDACTED] was driving his white BMW 740 with [REDACTED] in the front passenger seat and [REDACTED] and [REDACTED] in the backseat of the vehicle when they were pulled over by plainclothes officers in a gold Impala. The four were pulled out of the car and [REDACTED] was asked for his license and registration, but the officers barely looked at it. The plainclothes officers (approximately 3) were then joined by uniformed officers in a blue and white van. [REDACTED], [REDACTED] and [REDACTED] were thrown against the car and searched for no reason. The vehicle was also searched. "Detective Williams" ([REDACTED] heard another officer call him "Williams") then touched the inside of [REDACTED] "asshole" underneath his clothes ( he was wearing a "wifebeater" and jeans). A total of 6 officers were at the scene. [REDACTED] estimated that they were at the scene for about 15 minutes. He was never asked for any identification and did not see the officers filling out "stop & frisk" reports like they were supposed to. There were no arrests made at the scene. The officers then said, "Have a nice day," and let everyone go. No one was handcuffed at any point. [REDACTED] stated that the "whole world," or much of the neighborhood was watching this incident.

[REDACTED] also reported that on October 1, 2007 at approximately 12:30-1pm, he was driving on [REDACTED] in his black Dodge Charger with [REDACTED] in the front passenger seat when he noticed a blue Trailblazer behind him. The Trailblazer pulled [REDACTED] over, and "Detective Williams" emerged from the driver's seat and approached the vehicle. "Detective Williams" came to [REDACTED] door and instructed him to roll down his windows, take his keys out of the ignition, and place them on top of the car. "Detective Williams" opened the car door, pulled [REDACTED] out of the car, and began searching him. He was wearing blue jeans and a hooded sweatshirt on the incident date. Two other plainclothes officers, "white guys," who were also present for the first incident, were also there. One of the officers searched [REDACTED]. "Detective Williams" again "kept circling his finger inside" [REDACTED] "butthole." [REDACTED] feels as though he has been "raped" and he is "not gay." The officers also searched [REDACTED] car and "messed up" the interior, but he could not describe how. [REDACTED] went to Lawrence Hospital on 10/1/07, and [REDACTED] believes that due to "Detective Williams' dirty hands" he had bumps in his anal region. [REDACTED] did not see the officers fill out any paperwork; he and [REDACTED] were not handcuffed, issued summonses, or arrested. The incident took about 7-8 minutes and there were not many people around who may have witnessed the incident.

"Detective Williams" is described as a "Dominican" male with a bald head in his 30s. The other plainclothes officers were "white guys."
