Initial Complaint Narrative

On May 15, 2019, at approximately 1:30 PM, [REDACTED] and [REDACTED] were standing on the corner of [REDACTED] [REDACTED] in the Bronx. [REDACTED] saw PO1 and PO2 pull up at the corner in a grey Impala. [REDACTED] walked away because PO1 is always trying to apprehend him since they both dated the same woman. The woman told [REDACTED] that she would use PO1 to do whatever she wanted, such as apprehend [REDACTED].

When [REDACTED] walked away from [REDACTED] after seeing PO1 and PO2; PO2 walk up to [REDACTED] and said, "Why is that guy always walking away from us. The next time I catch him I'm going to slam him on the ground and plant everything I find on him". [REDACTED] told [REDACTED] what PO2 said to him. [REDACTED] did not hear PO2 because he walked away.

[REDACTED] stated that PO1 and PO2 arrested him before in January.
