This is in response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You requested:

All records, documents, emails, and other correspondence regarding or related to the 1991 Bell 412 Helicopter as well as any additional equipment attached to the aircraft. This aircraft has holds registration N411DE. This aircraft uses the mode-s code of A4D827 in hexadecimal. I request records documents, emails, privacy assessments, purchase orders, maintenance records, and other correspondence relating to the equipment.

Any records which may be responsive to your request are under the jurisdiction of DOE's National Nuclear Security Administration (NNSA). For this reason, I have transferred the request to NNSA to conduct a search of its files for responsive records and provide you with a response.
