It should be further noted and emphasized that "record" also includes records that have been placed in storage and records maintained by subcontractors, consultants, physicians employed, retained by or under some sort of contract, whether written, verbal or informal, with the United States Postal Inspection Service or any of its subsidiary offices and, in this regard, shall include but not be limited to all responsive records in the care, custody or control of any of the foregoing.

I request that responsive records be produced in their entirety, including all attachments, enclosures and exhibits. In the event that you determine that a record contains material or information that falls within the statutory exemptions to mandatory disclosure, it is requested that such material or information be reviewed for possible discretionary disclosure. Similarly, in the event that you determine that a record contains material or information that falls within the statutory exemptions to mandatory disclosure, it is requested that, in accordance with the provisions of 5 U.S.C. § 552(b), and any other applicable law, that all segregable portions of such records be produced.

Additionally, please provide me with your position as to which exemption you believe covers the material that you are not releasing, your reasons for invoking the exemption in each particular case, and an index of the withheld records. My wife has an urgent need for the requested records, which are for a personal and not a commercial use. Accordingly, pursuant to 5 U.S.C. § 552(a)(6)(A), we request your determination on release within twenty (20) days of receipt of this request.

KNOW ALL MEN BY THESE PRESENTS, that I, Denise P. Blackburn, with social security number 375-58-0626, of 1286 Remus, Kalamazoo, Michigan 49004, have made, constituted and appointed, and by these presents, do make, constitute and appoint Jerry T. Blackburn, my husband, of Kalamazoo County, Michigan, my true and lawful attorney, for me, and in my name, place and stead, giving and granting unto the said Jerry T. Blackburn, full power and authority to do and perform every act and thing whatsoever requisite and necessary to be done as fully and to all intents and purposes as I might and could do if personally present, here by ratifying and confirming all that my said attorney shall lawfully do or cause to be done by virtue hereof, and without intending to limit the foregoing, giving and granting unto my said attorney full power and authority:

- 1. To demand, collect and receive any and all monies and other property which may be due me or to which I may be otherwise entitled including monies or property from estates and/or trusts in which I am a beneficiary.
- 2. To endorse, negotiate or cash any check, bill of exchange, note or other instrument made payable to me.
- 3. - 15. To make application to any government agency for any benefits payable to me, and to endorse any checks or drafts made payable to me by any such agency including Social Security checks.
- 16. To cause to be drafted and/or to sign income tax returns, local, state and federal, and to endorse all tax refund checks, local, state and federal, and execute such other instruments with relations to the foregoing as may require my signature. - 17. To obtain, deal with, manage, control and supervise all insurance providing coverage for sickness disability and accident, major medical expenses, supplements to Medicare, disability income and otherwise as my attorney shall determine is in my best interests.
- 18. To provide for my needs, including but not limited to, medical, hospital, nursing and other health care, and to execute waivers, medical authorizations and such other approvals as may be required to permit or authorize care which I may need.
- 19. To make all decisions regarding my health care if I am unable so to do, including the decision to forego or terminate any treatment, procedure, therapy or nourishment (including food, water and oxygen) which serves only to prolong my life without reasonable prospects that the quality of my life will be enhanced by the same and upon the conclusion, if ever, of the same. Said decision to forego or terminate any treatment, procedure, therapy or nourishment shall not be made until extensive efforts have been made to assure that no feasible alternative exists or is likely to become feasible within a timely period and through means which would be reasonably available. I specifically direct that no heroic measures be taken to prolong my life without the reasonable prospects of improving the quality of my life if my death, with or without such measures, is inevitable or probable in the near future, or in the event that my mental or physical condition has deteriorated to the point that were I to recover the best could be hoped for is that I would be either permanently disoriented or totally dependent upon artificial means to sustain my life. My attorney-in-fact shall have the sole and absolute discretion to reach such conclusions, make such decisions and implement the same either by way of action or inaction.

This Durable Power of Attorney shall be governed by the laws of the State of Michigan.

This Durable Power of Attorney shall not be affected by my disability, except as provided by statute.

The powers herein given may be exercised in relation to any and all property, rights or privileges and obligations or liabilities which I now have, or may at any time hereafter have, either singly, or together with anyone else.

INVESTIGATIVE MEMORANDUM

- The basis for this investigation was the receipt of information obtained through Mr. John Rideout, Injury Compensation, Manager, Greater Michigan District, concerning the physical activities of Ms. Denise Blackburn. Ms. Blackburn has been receiving benefits under the Federal Employee Compensation Act (F.E.C.A.) as a result of an alleged on-the-job injury. Ms. Blackburn is currently on the periodic rolls.
- 2. A review of the Department of Labor's (DOL) Statement of Accepted Facts indicates on December 31, 1991, Ms. Blackburn sustained an alleged on-the-job injury when she lifted a tub from the top of a cage and felt something pull in her back. She sought medical attention the day of the injury and was released to return to work with the restrictions of no lifting, bending, twisting and was instructed to alternate between sitting and standing. Ms. Blackburn later stopped work on February 28, 1992 and returned to limited-duty on March 21, 1992. She again stopped work on April 21, 1992 and has not returned to work. After the work injury, Ms. Blackburn began to develop non work-related cervical problems. The claim has been accepted by the Department of Labor (DOL) for the following conditions: low back strain and protruding disc at L4-L5.
- 3. Based on this information and under the direction of the Postal Inspection Service, Ms. Blackburn was under surveillance during the months of January through May 2000. Her activities for the months of January through March were videotaped. Surveillance over two days in April and six days in May revealed no activities beyond her restrictions. An edited 6-minute VHS videotape of Ms. Blackburn's activities is submitted for your review (Exhibit 1).
- 4. On Monday, January 10, 2000, Ms. Blackburn was observed going to her second opinion examination with Dr. Magdi Gabriel, 320 West Fourth Street, Mishawaka, Indiana 46544. Ms. Blackburn was observed ambulating from her vehicle to the doctor's office and returning to her vehicle. Later that day, Ms. Blackburn was observed exiting her vehicle, ambulating to a McDonald's restaurant, eating at the restaurant, throwing trash from a tray into a trash receptacle and ambulating from the McDonald's restaurant to her vehicle (Exhibit 2).

- 5. On Tuesday, January 11, 2000, M: Yackburn was observed driving her vehicle to a local Harding's Supermarket. Ms. Blackburn parked her vehicle and ambulated while carrying her purse and grocery bags into the supermarket (Exhibit 3). She ambulated from the supermarket and entered her vehicle from the driver's side. She was observed driving back to her residence.
- 6. On Thursday, February 24, 2000, Ms. Blackburn was observed driving her vehicle to Parchmant Library. Ms. Blackburn parked her vehicle and ambulated into the library. She exited the library, ambulated to her vehicle, entered her vehicle from the driver's side and was observed driving to 5068 Keyes Street. A female exited the residence and entered the passenger side of Ms. Blackburn's vehicle. Ms. Blackburn was observed driving to a local Harding's Supermarket where she parked her vehicle. Ms. Blackburn exited her vehicle, carried grocery bags in both hands, and ambulated into the supermarket. A short time later, she exited the supermarket, lifted a grocery bag and assisted an employee who placed the bag into Ms. Blackburn's trunk. Ms. Blackburn also pushed an empty shopping cart across the parking lot (Exhibit 4). The female passenger was observed entering the driver's side. Ms. Blackburn drove to 5068 Keyes Street where the female passenger exited the vehicle. Ms. Blackburn drove back to her residence.
- 7. On Tuesday, March 21, 2000, Ms. Blackburn was observed driving to the local elementary school on Gull Road. Ms. Blackburn parked, exited the vehicle and ambulated into the school. A short time later she was observed ambulating out of the school, then driving to the side of the school. Ms. Blackburn parked, exited the vehicle and again ambulated into the school. A few minutes later, she was observed ambulating out of the school with a young male. Ms. Blackburn, while holding her purse with her right hand; leaned over and pointed with her right arm to the passenger side of the vehicle (Exhibit 5), where she directed the young male to enter. Ms. Blackburn then entered the driver's side of the vehicle and drove back to her residence.
- 8. In reviewing Ms. Blackburn's medical information as compared to the video surveillance, there appears to be inconsistencies between her stated inabilities and her observed physical activities. The observations of Ms. Blackburn demonstrate she might be exceeding her medical restrictions.


