## Effects of Government Shutdown

Due to a lapse in appropriations, the vast majority of FOIA staff, including all those who receive and conduct the initial review of FOIA requests, were furloughed between December 23, 2018 and January 26, 2019. Our immediate priority is to open and properly acknowledge each of the hundreds of FOIA requests received during the furlough to comply with our statutory and regulatory obligations. We are also continuing to process requests received prior to the government shutdown, and, as a direct result of the furlough, we anticipate it will take longer than normal to process all requests for the foreseeable future. We appreciate your understanding.

Please note, if you call BOP's FOIA office for a status update, we will have the same information generated by this page. Staff are generally unable to provide a date when BOP will issue a final response to a particular FOIA request.

The different statuses are:

- DAddRvwLog: We received at least one responsive records.
- Fee Related Hold: No action is being taken pending a requester's agreement to pay or actual payment of fees.
- Clarification Hold: No action is being taken pending a requester clarifying his/her FOIA request.
