This is in response to your Freedom of Information Act (FOIA) request in which you seek documents regarding the above-referenced individual.

After conducting a search of our database, no records were located regarding this matter. The database contains records of proceedings from 1988 forward. If your case occurred prior to that time, the location and date of proceedings will be required for special processing.

Please be aware that the EOIR is a component of the Department of Justice. EOIR is not the record holders for Immigration and Customs Enforcement (ICE) or U.S. Citizenship and Immigration Services (USCIS). Section 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA.
