Mrs. VanVranchken,

Thank you for the information you provided, and the important service your business provides. It is our opinion that in Phase 1 your event center, with your LDH food service permit, may operate within the guidance of a restaurant/bar. In reference to indoor wedding ceremonies, Phase 1 allows those to occur only in a place of worship setting. Further, receptions or other gatherings are not yet addressed in the current proclamation and supporting documents.

I am hopeful soon new guidance will be updated that will address more of your usages as we follow Federal recommendations and mitigation standards.

Thank you so much for being available to speak by phone yesterday. I appreciate the opportunity to work with you on this matter.

The purpose of this communication is twofold. First, to help clarify that indoor wedding gatherings (and indoor funeral gatherings) are permitted in Phase 1. Second, to help clarify that a particular business situated in my council district is a restaurant establishment and as such, is permitted to operate at 25% capacity with social distancing and other precautions applicable to restaurants in Phase 1.

Governor John Bel Edwards held a press conference May 11 regarding moving the State of Louisiana into Phase One of Reopening. Below are links to numerous news articles, each specifically includes information stating that Phase One allows wedding and funeral gatherings to be held indoors at 25% occupancy of the facility holding the gathering. In addition to the below list of links, I have attached several additional articles (Attached as "Additional Media") also specifically enumerating or highlighting that wedding and funeral gatherings are permitted in Phase One at 25% capacity.

Attached to this email (as Balcony Restaurant) is the most recent ATC Class AR Restaurant permit, the ATC description of Class AR restaurant permitted establishment, the most recent State of Louisiana Department of Health Office of Public Health inspection noting no violations, the most recent Louisiana Department of Health Permit to Operate as a Food Service Establishment, Certificates of Completion for the proprietors from the Department of Health and Hospitals Food Safety Certification Training and Testing Program as well as the occupancy capacity allowed on the premises. I hope this will serve to establish clearly that the Balcony Ballroom is licensed to operate exclusively as a restaurant establishment and as such is permitted to re-open for business in Phase One as of May 15 under Proclamation 58 JBE 2020, following all applicable guidance contained therein.
