This is in response to your letter dated January 28, 2020, received on January 28, 2020, appealing the adverse determination by the U.S. Immigration and Customs Enforcement (ICE), Freedom of Information Act (FOIA) Office in response to your FOIA request, requesting all ICE records pertaining to Jeandre Fouche, A# 216 486 423, COB: South Africa, 1996.

By letter dated December 20, 2019, the ICE FOIA Office advised you that "[a] search of the ICE Office of Enforcement and Removal Operations (ERO) for records responsive to your request produced 2 pages that are responsive to your request. After review of those documents, I have determined that portions of 2 pages will be withheld pursuant to [FOIA] Exemptions (b)(6), (b)(7)(C), and (b)(7)(E)" ERO is the office within ICE mostly likely to have records responsive to your request, should they exist.

You appealed the adequacy of the search, stating that you "are aware of the existence of responsive documents that should be in ICE's custody or control that were not produced. We therefore do not believe that a comprehensive search of all available records was performed"

Upon a complete review of the administrative record, and the search documentation which led to the determination on your FOIA request, ICE has determined that the search was adequate in all respects and was reasonably calculated to uncover all relevant documents. Therefore, ICE affirms the adequacy of the search conducted on your FOIA request.
