On Wednesday, August 26th, 2020, I was assigned this case for further investigation. On Tuesday, August, 25th, 2020, at approximately 2124hrs, Officer Davenport #322 responded to the Admiral's Cove Marina Café located at 300 Admirals Cove Blvd. in reference to disturbance call.

Upon arrival, Officer Davenport made contact with the victim/complainant [REDACTED] who advised the following: while eating dinner outside the club's café at approximately 2100hrs, he was confronted by Carlos Gavidia (W/M, 02/28/67), who was sitting inside the café. [REDACTED] explained while he was watching the television, which was positioned near Gavidia by the bar area, he observed Gavidia stand up and begin pointing at him. [REDACTED] stated Gavidia then walked outside, threw his hands in the air and stated to [REDACTED] "Fuck you, you fucking little Jew!" Gavidia then stated to [REDACTED] friend, who was sitting with him "Fuck you, you cunt!" [REDACTED] explained at that time, Gavidia's wife advised him to leave and she and Gavidia left the café.

[REDACTED] stated approximately 2-3 minutes after Gavidia left, he received a text message from Gavidia. The text message stated the following: "Your such a pussy You fucked with the wrong guy I'm coming for you you'll see you will see you little fucking piece of shit I've got nothing to lose but you have plenty like your life, you have no idea who I am. I want to get your little fucking friends flicking me off calling me names while we're at the fucking Marina Cafe you fucked with the wrong guy. And I don't play like you pussies I play for keeps your fucking done."



[REDACTED] stated he has no idea what prompted Gavidia to act this way towards him [REDACTED] further advised on Tuesday, August 11th, 2020, while he was eating lunch with his father at the café, he was approached by Gavidia. [REDACTED] explained that Gavidia was not wearing a mask, which made him uncomfortable due to his father being elderly. [REDACTED] advised he later received a text message from Gavidia. The text message stated: "Dude are we no longer friends because I support the president??? I come up say hello and you act like a dick." [REDACTED] responded "Don't care who you or anyone else supports, it's your right. Have some class" Gavidia then responded with "Have some class??? [REDACTED] Fuck you! Your classless piece of shit. Middle finger emoji."

On Wednesday, August 26th, 2020, Officer Davenport responded to [REDACTED] residence and obtained a sworn recorded statement from him which was captured on Officer Davenport's department issued Body Worn Camera. [REDACTED] explained the text message he received from Gavidia made him fear for his life and he wishes to prosecute against Gavidia. After reviewing Officer Davenport's report, I contacted [REDACTED] who provided me with Gavidia's phone number of (561) 529-6677. I conducted an Accurant check on the phone number which showed it is registered to Gavidia. I attempted to make contact with Gavidia via phone with negative results.

On Thursday, August 27th, 2020, at approximately 1247hrs, I received a phone call from (561) 529-6677; the individual on the phone identified himself as Carlos Gavidia. I advised Gavidia I was investigating an incident, which occurred at the Marina Café on August 25th, 2020. Gavidia advised he and [REDACTED] were involved in a verbal altercation on Tuesday, August 11th, 2020. Gavidia stated he texted [REDACTED] and asked him why the two were no longer friends. Gavidia advised on Wednesday, August 12th, 2020, the two were involved in another verbal altercation at the Clubhouse. Gavidia admitted on August 25th, 2020, he was involved in a verbal altercation with [REDACTED] at the Marina Café. Gavidia stated after the altercation he texted [REDACTED] I then read the text messages verbatim to Gavidia and he advised he did send those text messages to [REDACTED]; this conversation was recorded with my department issued audio recorder.

Based on the above described investigation, there is probable cause to believe the defendant Carlos Gavidia (W/M, 02/28/67) did write or compose and also send or procure the sending of any letter or inscribed communication, or electronic communication, whether such letter or communication was signed or anonymous, to [REDACTED] containing a threat to kill or to do bodily injury to [REDACTED] or a threat to kill or do bodily injury to any member of the family of [REDACTED] contrary to Florida Statute 836.10.
